

Rules of the "Architecture Bookshops" draw

The Fundació Mies van der Rohe is organizing **"Architecture Bookshops"** with the aim of promoting Barcelona's bookstores with a collection of architectural publications during the Barcelona Architecture Week 2020.

1. When?

Participation: between 7 and 17 May 2020

2. Who can participate and how?

Anyone who purchases an architectural publication and/or other related products from any of the following online bookstores:

- Laie.
- La Capell.
- Document.
- Mies van der Rohe Pavilion Bookshop.

People who have made a purchase of an architecture publication and/or other related products and are interested in participating must fill in the form on the following link: <https://mailchi.mp/miesbcn/l-librariesdarquitectura> and comply with the requirements established in these Rules.

Participants must save the purchase ticket to prove it in case they are winners.

3. Prizes

The prizes will consist of 4 lots of publications and products of art and architecture supplied by: Phaidon, Editorial Gustavo Gili, Tenov, dpr-barcelona, Editorial Puente Editores, Triangle Books, Actar, Beamalevich, Fundación Arquia, Cooperativa d'Arquitectes Jordi Capell and Fundació Mies van de Rohe.

Employees of participating bookstores and organizations as well as their first-degree relatives will not be eligible for any of the prizes.

4. Mechanics of the draw

The public draw between all the correctly filled in forms will take place on May 22 at 10 am in the Mies van der Rohe pavilion.

The director of the Fundació Mies van der Rohe or a delegate and two witnesses will draw lots through a process that guarantees the random selection of the winners of the 4 lots, and 3 alternates, in case any of the winners could not complete acceptance of the prize.

The result of the draw will be notified to all participants from the working day following the draw by the Fundació Mies van der Rohe via e-mail. Winners must expressly accept the prize, replying in the affirmative to the e-mail informing them that they have won to the same sender's account and attaching a photo of the purchase ticket, within seven working days from the receipt of notification of the prize.

If, for any reason, it is not possible to contact the winners or they do not accept the prize within the indicated period, it will be understood that the winners rejects the prize and will go to the substitute, who will also have to accept it within the specified period of seven working days. If it is not possible to contact him/her or, as the case may be, the next alternate, the prize will be forfeited, without any responsibility being attributed to the Fundació Mies van der Rohe.

The prize will be sent to the addresses provided by the winners.
